Applications must be received in the Home Office by September 7, 2021, 5:00 P.M., Central, in order to lock in current rates.

All funds on applications received by end of day on September 7, 2021, must be received in the Home Office no later than October 25, 2021, 5:00 P.M., Central, to receive the current rates.
