
## **Don't Delay Your Savings!**

## Postponing your savings 1 year could cost you \$21,301.

If you start your savings plan now you could have \$228,180 in savings after 16 years. Postponing 1 year would give you \$206,879. To get the same savings balance with a 1 year delay, you would need to save \$9,248 per year instead of \$8,385 per year.
