Applications must be received in the Home Office by September 28, 2021, 5:00 P.M., Central, in order to lock in current rates.

All funds on applications received by end of day on September 28, 2021, must be received in the Home Office no later than November 12, 2021, 5:00 P.M., Central, to receive the current rates.
