Connecticut, DC and Delaware: Compact-approved forms for New Business and inforce

Connecticut, the District of Columbia and Delaware previously joined the Interstate Insurance Product Regulation Commission, also known as the "Insurance Compact.

Effective immediately, financial professionals and agencies should begin using Insurance Compact-approved versions of forms for new cases and inforce policies from Connecticut, DC and Delaware.

> For general reference, the numbers for Compact-approved forms usually start with "ICC" instead of AGLC.
