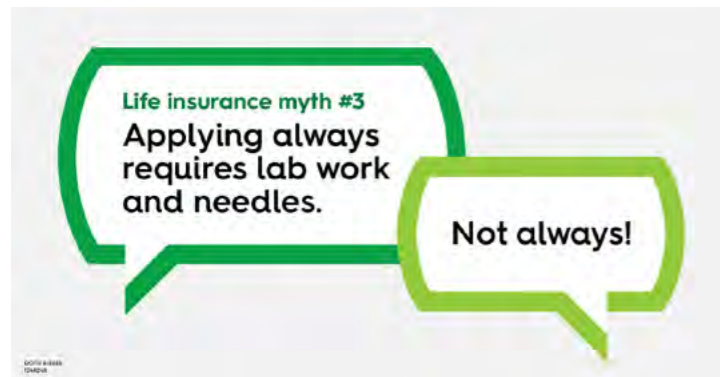

Email marketing



How it works:

1. The same email copy comes with three different header image options (shown below) and two file formats. Choose a header image and download the zip file. Then select the appropriate file format for your email marketing process: HTML if you plan to send the email using a marketing platform such as MailChimp® or Constant Contact, or OFT if you plan to send via Outlook.
2. Insert your logo and add the necessary information to the disclosure block: company name, contact information and marketing unsubscribe language.
3. Enter the email's subject line: Don't have life insurance? Getting it can be easy, simple and fast.
4. Select email recipients – remember that WriteFit Underwriting is meant for your healthiest clients between the ages of 18 and 60 – and send.
