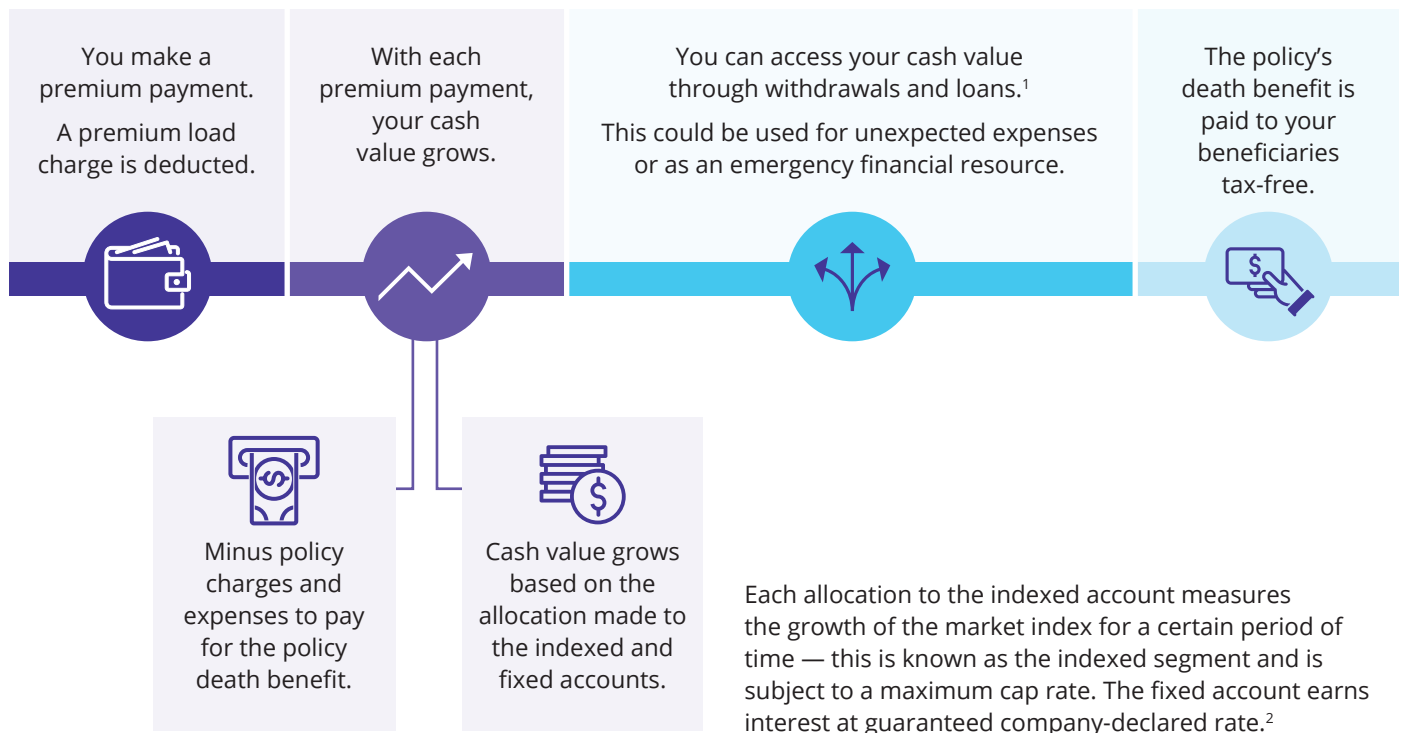

Indexed Universal Life 101

Indexed Universal Life (IUL) can provide lifelong protection with a death benefit that will be paid out to beneficiaries should something happen to you. In addition, your policy can grow cash value by earning interest based on positive changes in one or more market indexes.

How it works:



What happens if the market index drops?

Your cash value is protected because you will get a guaranteed minimum interest rate (known as the floor rate).³

How does Protective keep IUL simple?

Protective Indexed Choice UL allows you to earn interest on positive growth in the S&P 500 with a maximum rate of 8.0%.⁴ You'll also be protected from loss, as your policy will never return an interest rate less than 0%. Because we apply a more practical rate and keep policy fees low, you could have the potential to grow more cash value.
