- We will continue to accept applications for the HH750 product from **3/1/23 to 5/1/23**. Beginning **5/1/23**, only applications for Principal<sup>®</sup> Income Protector will be accepted.
- <u>GSI Exception</u>: Employer GSI cases quoted on HH750 with effective dates through **6/1/23** will be accepted.
- Backdating to save age will not be allowed beyond 3/1/23.
