

## New Annuity Rates Effective June 28, 2023

Americo has made some rate adjustments to our indexed annuities. New contracts issued on or after June 28, 2023, will receive the new rate.

To lock in current rates, applications must be received in the Home Office by June 27, 2023, 5:00 P.M., Central.

All funds on applications received by end of day on June 27, 2023, must be received in the Home Office no later than August 11, 2023, 5:00 P.M., Central, to receive the current rates.

Rates in **GREEN** indicate an increase from the previous rate and rates in **RED** indicate a decrease.
