# **Increased premium limits**

Effective: October 21, 2023

Our enduring strength and stability allows us to continuously evaluate new opportunities to improve the competitive value for our customers and distribution partners. As a result, we are excited to announce that we have increased our premium limits on the following products:

- Custom Guarantee® Universal Life 9 (CGUL9)
- Protection Builder IUL® (indexed universal life)
- Smart Builder IUL® 2 without Waiver of Surrender Charge (WOSC) Option Rider
- Builder Plus IUL® 3

Below are the updates to our premium limits, which apply to lump sums, 1035 exchanges, ongoing premiums, and multiple pending applications on the same client. Please be aware that there may be additional requirements for inforce policies that receive *unplanned premium* and are in CVAT corridor.

CGUL9	\$500,000	\$2,000,000
Protection Builder IUL w/ Premium Guarantee Rider (PGR)	\$500,000	\$2,000,000
Protection Builder IUL w/out PGR	\$2,000,000	\$3,000,000
Smart Builder IUL 2 w/out WOSC*	\$2,000,000	\$3,000,000
Builder Plus IUL 3	\$2,000,000	\$3,000,000

<sup>\*</sup>Smart Builder IUL 2 with WOSC will remain at the current premium limit of \$2,000,000.

Premium limits are reviewed on an ongoing basis and are subject to change.

#### SimpleSubmit® and illustration software

Starting **October 21, 2023**, all applications started and/or submitted using SimpleSubmit e-app, along with iPipeline web illustrations software, will be updated with the new annual premium limits. WinFlex will begin reflecting the new premium limits on **October 23, 2023**.
