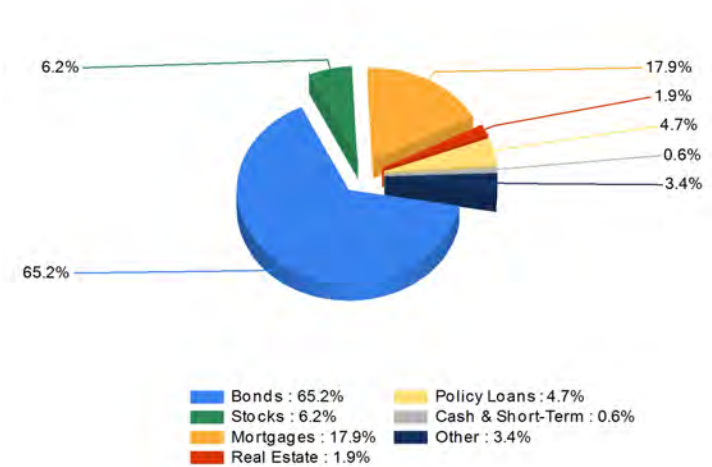

Invested Asset Distribution

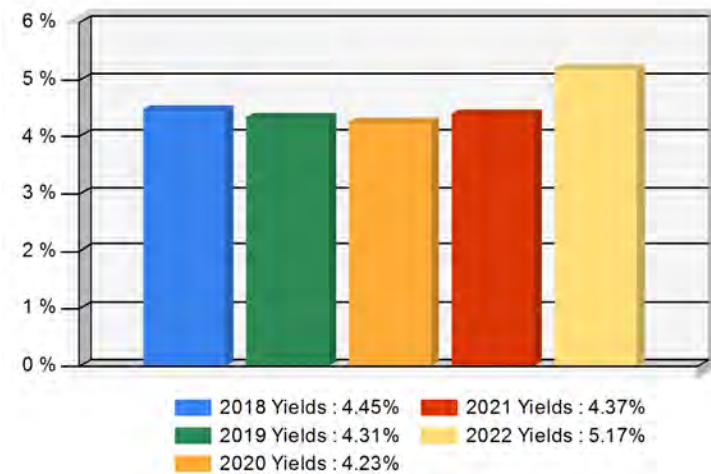
Total Invested Assets 2,465,326

Net yield on mean invested assets

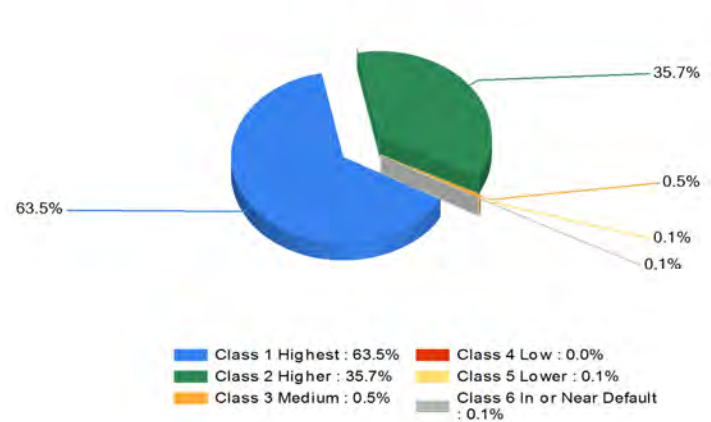
