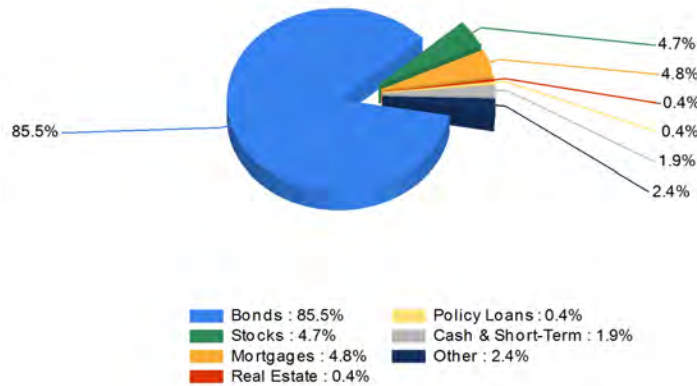

## Invested Asset Distribution

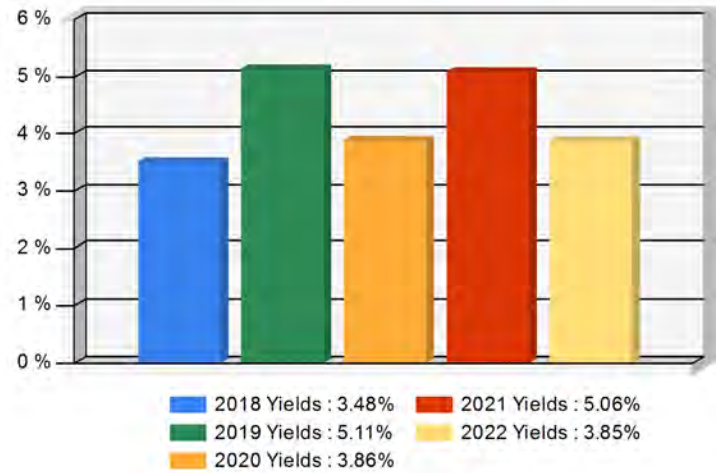

Net yield on mean invested assets

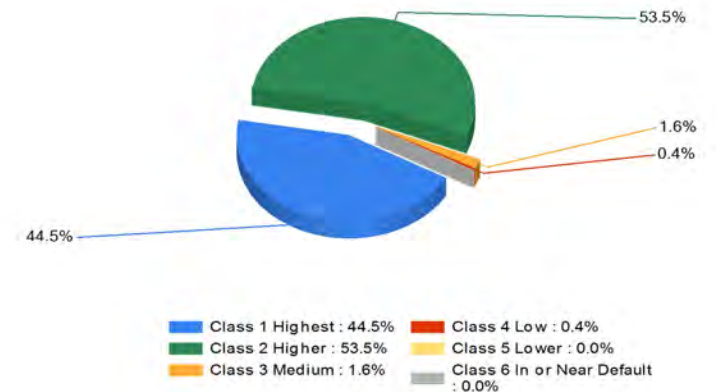
