#### New Annuity Rates Effective November 29, 2023

Americo has made some rate adjustments to our annuity products. New contracts issued on or after November 29, 2023, will receive the new rate.

To lock in current rates, applications must be received in the Home Office by November 28, 2023, 5:00 P.M., Central. All funds on applications received by end of day on November 28, 2023, must be received in the Home Office no later than January 15, 2024, 5:00 P.M., Central, to receive the current rates.

Rates in GREEN indicate an increase from the previous rate and rates in RED indicate a decrease.
