Important update: Web address changes for Connext and customer websites

Act now to update your bookmark settings

You will need to update your bookmarks to ensure uninterrupted access to your business.

Follow these steps to update your bookmark setting:

- Click on any of the links at left you need to update.
- When you reach the home page of that site, follow your browser's steps to add the URL to your favorites.
- If you previously bookmarked the site, be sure to delete the older bookmark.

If you encounter a broken Connext link after March 31, 2024

In addition to the new Connext home page address at <u>https://connext.corebridgefinancial.com</u>, any items that were housed in Connext also have new web addresses. This includes:

- Dashboards
- Pages
- Producer guides
- Bulletins
- If you bookmarked any Connext resources before the site moved in February, your bookmarks will not work after March 31, 2024, and you will get an error message if you use them.

If this happens, use the following steps to reconnect to and update your bookmarks:

- Log into Connext at its new address at https://connext.corebridgefinancial.com
- Navigate to the resource
- Create a new bookmark following your browser's guidelines for favorites/bookmarks, and delete the older favorites/bookmarks to avoid confusion.

If the web addresses changed in February, why did my older bookmarks continue to work for me?

To allow for a smooth transition, the older Connext addresses automatically redirected to the new addresses for a period of time. This allowed you to continue accessing Connext and its resources using older bookmarks. These redirects expire on March 31, so any attempts to reach them after March 31 will lead to error pages.

Has anything in Connext changed? Will my password work at the new address?

Nothing has changed at Connext or the customer portals. Site features, navigation and functionality will remain the same, and user names and passwords have not changed.
